BOARD OF DIRECTORS MEETING

April 7, 2008**

The Meeting of the Board of Directors of the League of Women Voters of Collier County, held April 7, 2008, at the North Collier Government Center, was called to order at 10:28 a.m. by President Chris Straton. **Upon motion made by Ms. Galton, seconded and unanimously carried, the Minutes of the Board Meeting held March 17, 2008, which was the only item on the Consent Agenda, were approved as presented.**

**Treasurer's Report**

The Treasurer's Report, showing a balance of \$10,531.70 as of March 31, 2008, was ordered filed.

**OLD BUSINESS**

**Womens Network for Change (WNC)**

Input from League board members concerning a list of survey questions for candidates for the 2008 elections that have been prepared by WNC, an organization formed by AAUW, was discussed, with numerous changes suggested and agreed on. It was decided that the final result might be fine tuned further in discussions with AAUW.

**Governance, Collier County School Board**

Ms. Straton provided an update. She has urged the School Board to take all steps to retain accreditation for CCPS.

**Social Policy Field Trip**

Following discussion and a pledge of support, **upon motion made by Ms. Schmelz, seconded and unanimously carried, the Board agreed to have League sponsor a Field Trip to Immokalee in 2009 as proposed by Social Policy Chair Ann Campbell.**

**Delegate to National Convention**

Ms. Galton announced that she would be unable to attend League's National Convention. Ms. Straton was then nominated, after which, **upon motion made by Ms. Schmelz, seconded and unanimously carried, Ms. Straton was approved as our delegate to National Convention.**

**NEW BUSINESS**

**LWVUS Immigration Position**

The immigration position recently adopted by the LWVUS was reviewed in detail and discussed, after which, **upon motion made by Ms. Schmelz, seconded and unanimously carried, it was agreed that LWVCC would officially support the**

**LWVUS immigration position.** It was decided that an email blast would carry this news first to our members. An amendment to the LWVCC Program, adding a goal and activities addressing immigration, will be prepared by Mr. Warshuer, with assistance from Ms. Straton, for presentation from the floor at the Annual Meeting. Ms. Parker volunteered to draft a press release to be sent to the recent Immigration Panelists, the BCC, the Constitutional Officers, and the Chamber of Commerce.

**Proposed State PMP Increase**
