- 1) Who answers the phone when you dial 911 to report a fire or medical emergency?
 - a) Collier County Sheriff's Department -- 12 intake positions with phones and radios
 - i) For fire emergencies, dispatches fire and police
 - ii) For medical emergencies, dispatches fire, EMS and police
- 2) Who provides your fire service today?
 - a) 5 independent fire departments, 2 dependent fire departments, 2 city fire departments
 - b) Independent fire departments – overseen by elected boards of commissioners
 - i) Big Corkscrew Island Fire Control & Rescue District
 - ii) East Naples Fire Control & Rescue District
 - iii) Golden Gate Fire Control & Rescue District
 - iv) Immokalee Fire Control District
 - v) North Naples Fire Control & Rescue District
 - c) Dependent fire departments – part of county government
 - i) Isles of Capri Fire and Rescue
 - ii) Ochopee Fire Control District
 - d) City fire departments – part of city government
 - i) Naples Fire Department
 - ii) City of Marco Island Fire Rescue
- 3) If you don't know, do you know how to find out?
 - a) Noted on your voter registration card
 - b) Call county sheriff's office
- 4) Who provides your emergency medical service today?
 - a) Since 1981, operated as a department in Collier County government, under direction of the Emergency Management Services Dept (Dan Summers) – which reports through Leo Ochs, Deputy County Manager, to County Manager Jim Mudd
 - i) 161 employees – including 145 field positions (NDN 7/7/06)
 - (1) Interviewing now to hire 28 new field workers for upcoming year (NDN 7/7/06)
 - ii) 30 ambulances (NDN 7/7/06)
 - (1) 22 ambulances are in service every day, usually staffed by 2 EMS workers (NDN 7/7/06)
 - (2) balance are backups (NDN 7/7/06)
 - b) Collier EMS is the only agency licensed to transport from the scene of medical emergencies (NDN 7/7/06) – others can apply to county for Certificate of Public Convenience and Necessity
 - 5) How are fire and EMS services paid for in Collier County?
 - a) Ad valorem taxes assessed as a millage rate times your property's assessed value
 - i) 1 mil is 1/10 of a cent per dollar of property value, or \$1 dollar per \$1000 of assessed value
 - ii) For a \$1M house, 1 mil rate = \$1000
 - iii) For a \$1M house, 4 mil rate = \$4000
 - b) Fire (rates per NDN 7/14/06)
 - i) Independent fire districts have taxing authority
 - (1) North Naples = 1 mil
 - (2) Golden Gate = 1 mil
 - (3) East Naples = 1.5 mil
 - (4) Big Corkscrew Island = 2 mil
 - (5) Immokalee = 3 mil
 - ii) Dependent fire districts' rate is set by the Board of County Commissioners
 - (1) Isle of Capri = 1.5 mil
 - (2) Ochopee = 4 mil
 - iii) City fire districts' rate is set by City government

- (1) less than 1 mil (Naples about ½ mil – per Jim Mudd interview with Jeff Lytle)
- c) EMS
 - i) Part of county budget (\$24M gross), partially offset by user fees (\$14M) → \$10M net cost (\$10.4M proposed budget for 2006)
- 6) Why has the county commission recommended that the independent fire districts consider merging?
 - a) According to the Naples Daily News (6/24/06):
 - i) Cost: idea was raised by Commissioner Fred Coyle at the end of 2 days of budget workshop hearings
 - (1) ..., “ Coyle said. ‘I think the fire districts can do a better job (of running EMS) than we can.’ ”
 - (2) “ ‘The fire districts are suspicious that we want to take them over,’ Coyle said. ‘I don’t want to do that.’ ”
 - (3) “Coyle spoke after the commissioners discussed ways to cut spending in the fiscal 2007 budget. He said getting rid of EMS would be a good way to cut spending.... The other commissioners enthusiastically agreed with Coyle.”
 - b) According to Jim Mudd in an interview with Jeff Lytle (One-on-One, 7/16/06):
 - i) Get rid of competition for employees between fire districts and EMS
 - ii) Stabilize service – less turnover
 - iii) Standardize service across the county
 - (1) North Naples is very good with some of the finest trained in the country; others are just getting by in terms of training, equipment and pay... what you can afford equates to service on the ground
- 7) What steps are required for the fire districts to merge?
 - a) Agreement of fire districts, including compromise on structural differences (e.g. tax rates, seniority, retirement packages)
 - b) Public hearings
 - c) Approval of State Legislature
 - d) Approval by voters
 - e) → could take years
- 8) What is the current status of this issue?
 - a) Fire districts created a fire services subcommittee in July that has begun to meet
 - b) Coyle said if fire districts don’t make progress toward consolidating within the next year, commissioners might put the issue up in a straw ballot in 2007 (NDN 7/2/06)
 - c) Meanwhile, on 8/14, North Naples and Bonita Springs fire districts agreed to take first steps toward merging their two districts
 - i) Bonita Springs Fire Department commissioners voted unanimously in favor of budgeting \$50,000 at their final budget meeting on 9/11 to hire a consultant to explore best ways for the 2 districts to merge
 - ii) The two districts have voted to explore prospect of sharing equipment and improving emergency communication between the agencies
- 9) How can you influence fire and EMS services in Collier County as an informed and active participant in government?
 - a) Become informed
 - b) Attend meetings
 - c) Vote and/or run for your fire district board (4 year term)
