Mimi Gregory, president of the Naples Council on World Affairs, will speak on “Women’s Rights in the Middle East” at our afternoon meeting. Actively involved in international affairs for the past 25 years, she has been on “Leadership Missions” with the Council to Lebanon, Kuwait and Egypt. Mimi’s contributions to various French organizations were recognized in 1990 when she was knighted by the French Government as a “Knight of the Order of Arts and Letters.” During the 90s she devoted a great deal of energy to helping refugees of the Balkan War which took place in her ancestral home country, the former Yugoslavia.

Mimi has lived and worked in Paris and is currently president of the Bonita Springs chapter of the Alliance Francaise, an organization she founded and that has grown to more than 250 members. She has served as Vice President of the National Board of the Alliances Francaises in the United States for three consecutive terms; serves on the board of the World Affairs Council of Boston; and is a member of the Executive Committee of the National Board of World Affairs Councils of America.

## RECOMMENDED BYLAWS REVISION ARTICLE VI

***Sections to be deleted are printed in bold italics; new sections are underlined.***

Section 2. Dues: Annual dues shall be automatically adjusted whenever there is a change in the state or national dues. The amount for local use shall be set by members at the annual meeting and shall be payable October 31. Any member who fails to pay her or his dues by January 15 of the following calendar year shall be dropped from the membership rolls. Dues received from those joining after April 1 shall be credited to the amount due the following October 31. ***The dues for an Associate members (student members and second family members living in the same household) shall be on half of the regular dues.*** Dues for student members, for a second individual or family member who shares the same household and for Associate Members shall be one half of the regular members dues. Associate members are persons under 18 years of age, non-citizens, and members of other Leagues who are seasonal attendees of the LWVCC.

### League of Women Voters of Collier County Proposed Program for 2006-2007

#### EDUCATION

- Support measures to encourage high academic achievement, educational enrichment, equality of opportunity, and meaningful parent and community awareness and involvement in our schools.
- Monitor the school improvement program at all times.
- Support adequate funding for public education.
- Increase member awareness of challenges confronting Collier County schools and of achievements attained by the District.
- ***Study the question: Does Florida have a fair and reliable accountability system that measures the achievement of all students whose education is provided by public expenditure?***
- Actively support the inclusion of social studies in the curriculum.

#### GOVERNMENT

- Monitor the Collier County Growth Management **and Comprehensive Plans for Collier County and the City of Naples.** and report back to members.
- ***Monitor*** Observe every regularly scheduled Board of County Commissioners, County Planning Commission, and Metropolitan Planning Organization meetings **elected boards and councils and appointed advisory boards** for League visibility. **good government practices.**
- ***Study charter government.***
- Increase member knowledge and take action on national LWV legislative priorities.
- Increase member knowledge and take action on state LWV legislative priorities
- ***Study the question: Should Collier County institute a single district within the county for primary and general elections? The study would address the concept of allowing voters to vote at any voting center.***
- Initiate action to redistrict Collier County Commission and School Board Districts for 2008 election, redistricting to be based upon criteria established for independent non partisan commission and the residence of sitting Commissioners and School Board members.
- Develop questions to be raised by our coalition partner The Women's Network for Change with candidates for the upcoming elections, obtain responses, and communicate responses as a means of educating our members about candidate positions on issues of interest to League.
- Encourage attendance at Southwest Florida Legislative Delegation meeting at Florida Gulf Coast University and encourage participation of other regional Leagues.
- Increase member knowledge of the 5 Collier County Constitutional Officers and understanding of their roles, responsibilities and current issues.

#### HOUSING

- Support a strengthening of the programs of Collier County's general purposes government and the cities of Everglades City, Marco Island and Naples, to implement the goals, objectives, policies and programs of their respective comprehensive Growth Management Plan Housing Elements, by means of rigorous enforcement of their land development codes and applicable building, environmental, health and housing ordinances.
- Encourage the elimination of substandard housing in Collier County and its municipalities and support efforts by all local government units to ensure that owners of rental units maintain their properties in conformance with local codes and ordinances.
- Encourage timely enforcement of applicable codes and ordinances to ensure that rental properties are well maintained and that tenants are assured of safe, sanitary, living conditions.
- Support the development of safe, sanitary alternative housing for farm workers, low-income families and retired persons living on limited incomes.

- When appropriate, support public funding to construct below-market-rate housing for low and very low-income families.
- Support efforts to provide home-ownership opportunities for low-income families.
- Study the ***issue of workforce housing in Collier County***. range of existing and publicly and privately proposed initiatives to address the workforce housing needs of Collier County, the housing needs of those residents whose income is between 80% and 150% of the county's median income, as defined by the county.

## INTERNATIONAL RELATIONS

- ***Study Monitor*** and evaluate how the United States is promoting peace in an interdependent world by strengthening international organizations and fostering long term development, with an emphasis on humanitarian policies as presented by LWVUS.
- Maintain a keen awareness of the major world events and stand prepared to respond to appropriate "Action Alerts."

## JUSTICE

- Monitor the operation of the adult and juvenile criminal systems in Collier County, including court functions, sentencing practices and detention facilities. Place particular emphasis on rehabilitation programs and alternatives to incarceration for appropriate adult and juvenile offenders in Collier County.
- Support programs for those who have been court-referred and who need continuing care and help for substance abuse.
- Monitor ***the operation of the Sheriff's DRILL Camp, including the aftercare component*** the development of the new prevention services unit of the Collier County Sheriff's Office.
- Monitor the operations of the Collier County Juvenile Detention Center and Assessment Center (JAC), with particular emphasis on the ***Assessment Center JAC.***
- Participate in the work of the Juvenile Justice Council including the JAC and the Substance Abuse Coalition.
- Support the PACE (Practical Awareness Cultural Education) Center program for girls.
- Monitor and participate in local task force's activities to curb human trafficking.

## NATURAL RESOURCES

- Monitor and comment on amendments/revisions to both the Collier County and City of Naples Comprehensive Plans and Land Development Regulations that affect our natural resources.
- Monitor various Collier County and Naples City Boards and Committees that are concerned with natural resource issues.
- Support measures that link land use and water use planning.
- Monitor the progress of the Comprehensive Everglades Restoration Plan and continue participation in Everglades Restoration through the Everglades Coalition.
- Support the City of Naples Land Trust efforts to preserve green-space.
- Encourage and participate in Conservation Collier, Collier County's land acquisition program.

- Monitor and support local efforts to provide basic health care to those in all age groups not otherwise covered.

### **Government Committee Annual Report**

The Government Committee conducted Government 101 which was a 2 ½ day opportunity to meet with the Constitutional Officers, Board of County Commission and state and federal legislative aides. Two Government 101-Short Courses were also conducted. Members were provided with a detailed explanation of the Collier County transportation plan for the next 25 years. We also had the opportunity to learn about Florida's Sunshine Laws and how it affected membership on Commissioner appointed committees. We initiated a Book Discussion Group, attended the Collier County Legislative Delegation, continued our involvement with Action Alerts at the State and National Level, attended the Southwest Florida Regional Delegation Forum at FGCU, conducted a Lobbying Workshop for our members and hosted a Transportation General Meeting. League participants included Ann Allen, Susan Bookbinder, Sandra Brown, Sheilah Crowley, Joyce Evans, Nancy Kahn, Linda Olbrych, Sandy Parker, Kathy Ryan, Gladys Warshauer, Trudy Weisberg, Stephen Weisberg, Nancy White, and Nancy Wolfe. In partnership with the Social Policy and Justice Committee we have begun the study of Homeland Security in Collier County.

### **Justice Committee Annual Report**

The Justice Committee has focused on juvenile issues this year. In addition to visiting the Juvenile Detention and Assessment Center and learning about their assessment and screening tools, members heard about juvenile probation, the work of the Gang Unit and the Delinquency Prevention and Enforcement Bureau of the Sheriff's Office, and the newly formed Substance Abuse Coalition of Collier County, Inc. The Committee was concerned to learn about the high recidivism rate for early D.R.I.L.L. graduates, which resulted in the closing of D.R.I.L.L. in December 2005. However, we are encouraged by the ground breaking of a new PACE Center for Girls, which will be able to serve 80 girls, and by the new Services/ Mental Health initiatives of the Sheriff's Office that will be available to both arrested and non-arrested youth 8-18. We are also encouraged by the plan to open a 24/7 residential drug treatment program for juveniles at the former D.R.I.L.L. site. These activities are consistent with the Florida League's Juvenile justice position which is "... a juvenile justice system that encourages diversion and recognizes the special concerns of children and their families."

The committee has also maintained its interest in the work of the Coalition Against Human Trafficking and joined the Government Committee in visiting the new jail.

We thank members Ann Allen, Barbara Bartlett, Ann Campbell, Christine Greider, Renee Hansen, and Duffy Holland who monitor and participate in the activities of various justice related agencies and coalitions in the community and always have the welcome map out for new committee members.

### **Housing Committee Annual Report**

League has strong positions regarding housing for very low and low income households. We discovered, however, that these positions did not address the serious housing crisis in Collier County for households with incomes above poverty levels but unable to afford market rate homes. This is the level we have termed gap housing.

This year our committee began a study to list options available in the private and public sectors, learn what other communities have done, and develop criteria to evaluate the various solutions that address the housing situation.

We began our monthly committee meetings in November with a report on the local Red Cross response to Hurricanes Katrina, Rita and Wilma by resident experts Ann Bleakley and Pat Lawrence. We continued with the disaster response/Homeland Security theme in December with Judith Nuland of the Collier County Health Department. In January, Don Williams of the Mental Health Association of Collier County addressed the mental health needs of hurricane victims along with the many education and prevention services provided by his agency. We revisited Universal Pre-K and quality child care services in February with a presentation by Jean Mekeel of Step By Step. In March, the subject was "Meeting the Health Care Needs of the Underserved in Collier County" with a most informative presentation by Dr. Keith Riley, Medical Director of Collier Health Services, Inc. (CHSI), and the Ronald McDonald Care Mobile.

Dr. Riley came to Collier as the first public health dentist in 1965 when the permanent population was 3,800 and there were 10,000 migrant indigent children; now there are 40-50 thousand. Dr. Riley says that the needs are the same, just more people! He spoke of the services provided by CHSI throughout the county including Horizon Primary Care Center in Golden Gate, the only one for indigents in the county. The needs are great and the problems dizzying! (Too many to include here.) We will be watching the progress of the exciting new program involving groups of FSU medical students who will be coming to Immokalee for training.

At our final meeting on Wednesday, April 12, we will return to emergency response issues with Collier County Emergency Management Director Dan Summers and Emergency Medical Services Director Jeff Page. As always, the breakfast meetings are at Crissy's Wildside Café at 8:00 a.m. with a cost of \$8.50. ### **Natural Resources Committee Annual Report**

The past six months have seen a wide variety of environmental issues in the news - locally, regionally and nationally. The following issues were of primary focus for Natural Resources during the past year.

#### **Defense of the Endangered Species Act**

Last fall, Congressman Richard Pombo (CA) introduced a bill (HR 3824 – the Threatened and Endangered Species Recovery Act of 2005) in the House that would have seriously weakened the Endangered Species Act. Our local League voiced concerns over this Legislation. Unfortunately, it was quickly passed through the House and approved. The Senate is now taking up the issues and the results seem uncertain at this time. While a comprehensive look at the Endangered Species Act is likely overdue, the result should be a comprehensive plan for listed species protection and recovery, not the systematic dismantling of the Act. In order to provide for recovery and the protection of habitat for listed species, the Senate will likely need to start from scratch on a reauthorization bill. We will wait to see....

#### **Water Woes**

It seems that 2005 was a year of tremendous water problems, which are continuing into 2006. Red tide blooms are occurring in a pattern considered by some to be more frequent, of longer duration and more damaging than ever before. In addition, blue-green algae has been plaguing our inland waterways to the north in Lee County. With the continued discharge of waters from Lake Okeechobee through the Caloosahatchee River, there are serious questions being asked by many, including the Lee County Board of County Commissioners, as to what our South Florida Water Management District intends to do to protect water quality. Again, we wait to see....

#### **Southwest Florida Basin Rule Challenge**

Our League chapter sent a letter to the South Florida Water Management District in support of creating a new set of rule for water treatment on new development project in Southwest Florida. This new rule has been in the works for many months and has been discussed in numerous stakeholder meetings. The hope is that a new standard, or rule, will be drafted to set the criteria for water treatment and management in new residential development projects. At this time, the District and the stakeholders are still working on moving the draft rule through the rule-making process. We are hopeful that this standard will be the model for statewide water quality in the future.

#### **Everglades Coalition**

Continued advocacy for restoration and constant vigilance for securing water for nature first was the reiterated theme for this year's Coalition meeting. While this is not a new theme, the Everglades Coalition Conference was a great opportunity to become reinvigorated. While the conference had an overall upbeat feel, there is still tremendous concern on the part of many environmental groups that land acquisition south of Lake Okeechobee in the sugar farming areas needs to be a more central focus in order to ensure that restoration of the Everglades is successful. Restoring the flow of water south of the lake cannot occur if there are sprawling subdivisions on former sugar fields. Another concern is there is no completed contingency plan if Aquifer Storage and Recovery (ASR) technology - the concept of injecting water into the ground to be withdrawn later - does not work as intended for storing the necessary water for restoration.

### Justice Committee Meeting

Mon., March 13 the Justice Committee met with The Honorable Lauren Brodie to learn about the newly formed Juvenile Substance Abuse Coalition, whose mission is education, detection, and prevention of substance abuse among juveniles. It represents the merger of three former groups and is presently housed in the Administration Center of Collier County Schools, with a hotline to the David Lawrence Center. The emphasis this first year is on public awareness. The Coalition plans to have booths at school Open Houses to educate the public about the existence of the Coalition and its goals. The National Guard provided training sessions for the staff. A search is presently being conducted for an Executive Director of the Coalition, and a grant writer, Barry Williams, has been hired and housed in an executive suite with a phone.

The Department of Juvenile Justice is creating a day treatment center and a live-in substance abuse treatment center at the former Drill Academy. 85% of juvenile arrests are drug related. Every third day a child goes to an emergency room for treatment of a drug overdose. Despite the prevalence of juvenile substance abuse, the schools provide only one health class to address this serious topic.

Judge Brodie took us through the court processing of juvenile offenders, beginning with their arraignment, the appointment of a public defender if necessary, the requirement that an adult must accompany the juvenile to court, the requirement of parental involvement which may be court ordered under threat of arrest if necessary, and the paucity of diversion programs, which results in Collier County having the highest juvenile commitment rate in Florida. Judge Brodie spoke of some of the many problems confronting the juvenile justice system, such as having only one Creole-speaking deputy despite the increasing Haitian population.
