★ ★ REGISTRATION and VOTING ★ ★

**YOU MAY REGISTER IF:**

- You are a citizen
- You will be 18 years old by Election Day (You may pre-register at age 17, or if you have obtained a Florida drivers license before your 17th birthday but cannot vote until age 18.)
- You have had your civil rights restored
- You are a resident of Florida and of Collier County, and have *NEVER*
  - been convicted of a felony
  - been adjudicated mentally incompetent

*You must be registered at least 29 days before any election. Your Registration Identification card will be mailed to you.*


**HOW TO CHANGE VOTER INFORMATION:**

You may complete a voter registration application that indicates a change of name, party affiliation or address or you may complete an affirmation for changes at the polls.

**THREE WAYS TO VOTE:**

- 1. Early Voting** starts 15 days prior to Election Day at designated sites. For information and sites, visit the website: [colliervotes.com](http://colliervotes.com) or call the Elections Office.
- 2. Election Day Voting:** You must vote in the Precinct where you reside, which is noted on your Voter Registration ID card. (Early Voting and Election Day Voting both require a photo ID and signature sample.)
- 3. Absentee Voting:** Contact the Elections Office to request an absentee ballot, which will be mailed to you two weeks prior to each election. Voted ballots must be received in the Elections Office by 7:00 p.m. on Election Day.
